



The mission of Danville Central Christian Church Foundation, Inc. is to support and expand Christ's ministry, by encouraging, managing and distributing bequests, gifts and endowments. We are committed to being good stewards.

The Danville Central Christian Church Foundation, Inc. was established in order that friends and members of our congregation might have an opportunity to extend their generosity by donating to a permanent fund. The principal of the foundation fund has grown from an initial gift of \$10,000 in 1978 to assets currently totaling over 1.8 million dollars. All legacy gifts are managed by a board of directors elected from the congregation; the gifts become a permanent fund in the investment portfolio.
